

General Smedley D. Butler Detachment #741 Marine Corps League General Meeting Minutes – 2 December 2014

Commandant: Commandant Paul Ferguson called the meeting to order at 1800 and the regular opening ceremonies were conducted. Officers present were Commandant Paul Ferguson, Sr. Vice Commandant Dominic D'Alessandro, Judge Advocate Bernie McGinley, Paymaster Bob Spano, Adjutant Jack Kelly, Chaplain Chris Bush, Sergeant-at-Arms Charles (Bud) Davis, Service Officer Con McGinley, Director Roger Godfrey, Director Bill Kinney, Director Ed Seidl, and Junior Past Commandant Jim Herbst. Paul Ferguson mentioned that Gunnery Sergeant Jesus Melendrez of the Folsom Reserve Center is joining the Detachment as a regular member, but since this meeting is the annual Christmas dinner meeting, his swearing in ceremony will be scheduled for the January 2015 general meeting.

<u>Minutes</u>: George Boyajian made a motion to accept the minutes of the 3 November 2014 general meeting as published in the *Scuttlebutt*. Bud Davis seconded the motion and the motion passed.

Officer Reports:

<u>Chaplain</u>: Chris Bush mentioned that he had visited Jr. Vice Commandant Jack McLeod in the hospital after Jack McLeod had had heart surgery. Chris Bush mentioned that Jack was doing well and that he was improving each day. He was out of ICU and was expected to be sent to a re-habilitation facility in the near future.

Adjutant: Jack Kelly reported that a number of letters of thanks for donations made by the Detachment had been received. Letters of thanks had been received from the Liberty USO in Philadelphia, PA, Operation Homefront in San Antonio, TX, the Semper Fi Fund in Oceanside, CA, the Fisher House Foundation in Rockville, MD, and from the Marine Corps League Foundation in Merrifield, VA. A letter was received from Guy Fizzano, Board President of the Delaware County Veterans Memorial Association, expressing his appreciation to Jim Donegan and the other members of the Detachment's Color Guard for serving as the Color Guard at the Association's Freedom Medals Awards Dinner on 13 November 2014. A note of thanks was received from the Martin's Run Retirement Community, thanking Detachment's Color Guard for participating in Martin's Run walk against dementia. A letter was received from the St.Thomas More Alumni Association, thanking Detachment member Dan Fitzpatrick for participating as a bugler in a recent service. The Alumni Association also donated \$100.00 to the Detachment. A letter received from the Liberty USO at the Philadelphia International Airport invited Detachment members to a tour of the Center to meet some of their staff, volunteers, and military guests. This invitation will be discussed at the January 2015 general meeting, to determine if there is any interest.

<u>Paymaster</u>: Bob Spano reviewed the paymaster's report as of 30 November 2014. There were no questions raised on his report.

Marine of the Year: Ben Sides had distributed ballots for voting for the Marine of the Year for 2014 earlier in the meeting. He asked the members to mark their vote on the ballot, and he would collect the ballots at this point in the meeting. The three finalists for the Marine of the Year were Paul Ferguson, Dominic D'Alessanro, and Jim Herbst. The announcement of the Marine of the Year will be made at the January 2015 general meeting.

Con McGinley had brought his award in to the general meeting for those who desired to see the award. George Boyajian mentioned that he had attended the dinner and he mentioned that the entire evening was outstanding.

Bill Kinney also mentioned that he had talked to Jack McLeod that afternoon and he mentioned that Jack was feeling better and was improving following his surgery. Bill mentioned that Jack McLeod was due to be released shortly and he would be going to either Dunwoody or to Bryn Mawr Rehab before going home.
