The Legend Continues ...



One of the outstanding publicity coups was the reenactment of Civil War battles staged by B.G. Butler and the Marine Corps in the 1920's. The Battle of the Wilderness, 1921... Battle of Gettysburg, 1922... Battle of New Market, 1923... Battle of Antietam, 1924.

These reenactments were large scale affairs (that at Gettysburg included the 4th Marine Brigade, composed of the 5th and 6th Marines, plus a battalion from the 10th Marines for artillery support) attended by literally tens of thousands of onlookers.

Historical correctness was not particularly good. At Gettysburg, Marine aircraft gave a demonstration of air combat, accompanied by an attack that included tanks and mortars. While at the Wilderness, the Marines conducted an amphibious assault across the Rappahannock River. These a-historical elements were critical to the primary purpose of the reenactments, to gain a favorable press for the Marines Corps.

During the reenactment of the Wilderness Battle, Butler became involved in one of the oddities of the American Civil War: the missing arm of the Confederate General Thomas "Stonewall" Jackson.

Going back in history, the saga of Jackson's arm began on the moonlit night of 2 May 1863. After a day of bloody fighting at Chancellorsville, Jackson and several aides journeyed beyond the front lines on reconnaissance and as they returned in the darkness, Southern troops opened point blank fire at these shadowy figures coming from the Union lines. Jackson was hit twice in the left arm and once in the right hand and was knocked from his horse. The General was carried several miles by stretcher to a field hospital where his left arm was sawed off, two inches below the shoulder. Jackson's personal chaplain, Rev. Beverly Lacy, snatched the severed arm from the ground outside the surgeon's tent and rode a mile to his brother's estate, "Ellwood" and buried it in the family cemetery on 3 May. A week later, Jackson died from pneumonia in Richmond where he had been taken and was later buried in Lexington, Virginia, the site of the Virginia Military Institute where he had been a teacher.

The estate, Ellwood, changed hands during the Civil War and Union forces often camped there.

It wasn't until 1903 that one of Jackson's aides marked the spot of burial with a granite block. Nealy two decades later, in 1921, the war games were held across the Spotsylvania and Orange Counties, exercises that President Warren Harding watched from Ellwood's front lawn.

Butler, hearing, but not believing, that Jackson's arm was buried nearby sent a platoon to dig in the cemetery and arm bones were found in a wooden box.

Butler reburied the arm in a metal case, adding a bronze plaque in tribute and Civil War devotees have come near and far to view the knee-high granite tombstone that marks the burial site.



Over the years there have been no official efforts to have the arm exhumed and placed with the rest of the body in Lexington and there lies an off historical attraction in a Virginia Park thanks to General Butler.

General Meeting Minutes – 5 April 2010

Commandant: Commandant Dan Luty opened the meeting at 1930. The normal opening ceremonies were conducted. Officers present were Commandant Dan Luty, Sr. Vice Jim Herbst, Jr. Vice Jack McLeod, Judge Advocate Paul Ferguson, Adjutant Jack Kelly, Paymaster Bob Spano, Chaplain Chris Bush, Sergeant-at-Arms Jim Ross, Service Officer Con McGinley, Director Bernie McGinley, Director Ed Seidl, and Jr. Past Commandant Earle Drake.

Minutes: George Boyajian made a motion to accept the minutes of the 1 March 2010 general meeting as published in the *Scuttlebutt*. Paul Ferguson seconded the motion and the motion passed.

Officer Reports:

Adjutant: Jack Kelly reported that a number of letters of thanks had been received from organizations that donations had been given to by the Detachment. Letters of appreciation were received from Soldiers' Angels, Operation First Response, the St. Vincent DePaul Society, and the Gideons International, as well as several other organizations.

Chaplain: Chris Bush mentioned that Joe Mensack had been in the hospital. He also mentioned that Bob Cosgrove was in the hospital for a knee operation.

Sr. Vice: Jim Herbst mentioned that the spring dinner is scheduled for 7 June 2010, beginning at 1800. This is the general meeting in which the Detachment's scholarships are awarded. The cost of the dinner is \$12.00 per person, and the deadline for reservations is 1 June 2010. Other dates for upcoming events were recently published in the *Scuttlebutt*. Jim Herbst also mentioned that he would appreciate assistance and feedback for upcoming trips or events. New membership kits are available by contacting Jim Herbst.

Jr. Vice: Jack McLeod reported that the Help Our Heroes campaign will continue this year. He also reported that Bob Spano and Jack Kelly had joined him in presenting an "Angel of Appreciation" to Ms. Judy Spires of Acme Markets for her support of Detachment events at Acme Markets locations during 2009. The angel was a beveled glass representation created by Paul Ferguson. Jack McLeod also mentioned that the Help Us Help Others campaign will begin on 17 April 2010. Those members who have participated in the past will be contacted shortly, and others were invited to participate.

Paymaster: Bob Spano presented the paymaster's report as of 31 March 2010. George Boyajian made a motion to accept the paymaster's report as received. Earle Drake seconded the motion and the motion passed.

Service Officer: Con McGinley indicated that he had a handout with information pertaining to Desert Storm veterans.

Anyone interested in the information should contact Con McGinley.

Jr. Past Commandant: Earle Drake mentioned that three Americanism presentations are scheduled for local elementary schools. He also mentioned that two parades are drawing near, the Memorial Day parade and other events on Memorial Day, and the annual July 4th parade. He also mentioned that a petition is being made to the State of Pennsylvania to erect an historical marker on General Smedley D. Butler on West Chester Pike.

Commandant: Dan Luty mentioned that the Detachment had received an invitation from the Chester County Detachment to participate in a memorial event at Fort Mifflin at Hogg Island on 4 July 2010. The time of the event was not known, and it may conflict with the Detachment's participation in the annual July 4th parade. Further information will be determined. Dan Luty also reminded everyone of the March of Dimes walk on 24 April 2010. He also mentioned that an invitation had been received from a local resident for members to join him at a cookout following the July 4th parade. Harry Kaufman was then called upon, and he provided information on an upcoming event sponsored by the Walk for the Wounded. The event is scheduled for 22 May 2010, and planning for the event is progressing.

Committee Reports:

Adopt-a-Highway: John Burfete mentioned that the first adopt-a-highway event is scheduled for 11 April 2010, beginning at 0830. John Burfete mentioned that a reminder e-mail would be sent out later this week.

Awards: Harry Kaufman presented a Certificate of Appreciation to Commandant Dan Luty that had been received from the Upper Darby Detachment for assisting their detachment with a recent golf tournament. In addition, Earle Drake recognized Aleta Krauss as another member who had recently completed the instruction course on the proper methods to conduct military funerals.

Color Guard: Joe Conigliaro was not in attendance, but Earle Drake mentioned that the Color Guard had participated in the opening ceremonies of the Marple Little League this past Saturday. Those present were Harry Kaufman, Jim Robinson, Bernie McGimley, Earle Drake, Joe Conigliaro, and Jack Kelly. Lloyd Spangler ably served as the bugler.

Honor Guard: Wayne Barner reported that 18 military funerals were conducted during March, and the year- to-date total is 57.

Marksmanship: Gene Kern reported that two pistol matches are coming up, with the first one scheduled for 24 April 2010. Additional shooters are welcome. Gene Kern also mentioned that a Department of Pennsylvania match is scheduled for 4, 5, and 6 June 2010, at Indiantown Gap, PA. Release forms for this event need to be completed and returned by participants by 1 May 2010.

Property: Bob Spano mentioned the annual Villanova NROTC Spring Review, scheduled for 20 April 2010. He mentioned that the Detachment provides a K-bar and a case to a deserving mid-shipman, and the proper supplies have been ordered for this year's presentation and for several years in the future. He has also been in contact with the Knights of Columbus regarding access to a storage room here at the hall. Some items need to be removed from the storage room before our Detachment can begin using it.

Scholarships: Wayne Williams provided an update on the Detachment's scholarship programs. Eight scholarship applications have been received for the annual Detachment scholarships available. For the one time scholarship program for students in the Marple-Newtown and West Chester School Districts, only one application has been received so far, but others are anticipated.

Toys for Tots: Dan Luty mentioned that certificates had been received for those store locations where Toys for Tots boxes had been placed last year. The certificates will be printed and will be ready for distribution at the next general meeting. Those members who assisted with the distribution of boxes will be asked to assist with the distribution of the certificates.

V.A.V.S.: Con McGinley mentioned that the next bingo night at the Coatesville Veterans Hospital is scheduled for 12 April 2010.

Unfinished Business: No items of unfinished business were raised.

New Business: Jim Ross mentioned that the spotlight was not properly aligned on the colors on the flagpole outside. This would be looked into with the Knights of Columbus.

Bob Spano reviewed those organizations that had been discussed and recommended at a recent officers meeting for consideration by the membership for donations. George Boyajian made a motion to donate \$1,000.00 to each of the following organizations: (1) Coatesville VA Medical Center, Coatesville, PA; (2) Fisher House Foundation, Rockville, MD; (3) The Injured Marine Semper Fi Fund, Oceanside, CA; (4) Operation First Response, Culpeper, VA; (5) Upper Main Line YMCA, Berwyn, PA; (6) The USO, Philadelphia International Airport, Philadelphia, PA. Bernie McGinley seconded the motion, and the motion passed.

Jack McLeod provided information concerning a legal issue concerning the death of Lance Corporal Mathew Snyder. Protestors (from Westboro Baptist Church in Topeka, KA) appeared at his military funeral several years ago, and his father later sued the protestors. Mr. Snyder won his case, but the verdict has since been overturned, and he has been ordered to pay the court costs of about \$16,000.00 to the protest group. These costs have since been taken care of by TV personality Bill O'Reilly. Other costs could arise. (Any funds collected over and above those needed will be donated to charity.) Jack McLeod made a motion to donate \$250.00 to the cause of

further court costs to assist Mr. Snyder in this matter. Earle Drake seconded the motion and the motion passed.

Good of the League: Jim Herbst mentioned that the Delaware County Detachment is sponsoring a bus trip to Marine Corps Headquarters at 8th and I Streets in Washington, D.C. for the Evening Parade. The trip is scheduled for 20 May 2010 and the cost is \$50.00 per person.

Harry Kaufman provided information on a spaghetti dinner sponsored by the American Legion in Havertown. The event is scheduled for 24 April 2010, beginning at 1800.
