We regularly inquire of those organizations as to whether they are adequately funded. Over the past nine years, we estimate that over 1000 individuals/families have benefited from our efforts!**

General Meeting Minutes – 5 July 2016

Commandant: Commandant Dominic D'Alessandro called the meeting to order at 1930. The regular opening ceremonies were conducted. Officers present were Commandant Dominic D'Alessandro, Sr. Vice Commandant Dominick Mattioni, Jr. Vice Commandant Jack McLeod, Paymaster Bob Spano, Adjutant Jack Kelly, Chaplain Chris Bush, Service Officer Jim Herbst, Director Roger Godfrey, and Director Bill Kinney. Jim Herbst served as the Sergeant-at-Arms for the meeting.

Application for Membership: Commandant Dominic D'Alessandro introduced John Ferraro as a potential member. John Ferraro had served in the United States Navy. After a brief introduction, George Boyajian made a motion to accept John Ferraro as an associate member. Bob Wells seconded the motion and the motion passed. Commandant Dominic D'Alessandro administered the oath of membership and John Ferraro was sworn in as an associate member of the Detachment.

Minutes: George Boyajian made a motion to accept the minutes of the 7 June 2016 general meeting as published in the *Scuttlebutt*. Bob Wells seconded the motion and the motion passed.

Officer Reports:

Adjutant: Jack Kelly reported that letters of thanks had been received from the Fisher House Foundation in Rockville, MD and from the Semper Fi Fund in Oceanside, CA for donations made by the Detachment to those organizations. In addition, a letter of thanks was read from Cindy Hamilton and Bonnie Fryer, who had been presented with plaques from the Detachment. Both ladies were very helpful in working with Roger Godfrey and assisting in the Help Us Help Others Campaign at the Booth's Corner Farmers Market in Boothwyn, PA. Jack Kelly also read a note of thanks from Jonathan Monkemeyer, one of the scholarship recipients in June 2016. Lastly, a letter of thanks was received from the Upper Darby MCL Detachment, thanking our Detachment for a donation made to the Upper Darby Detachment's Youth Physical Fitness Program.

Sr. Vice Commandant: Dominick Mattioni reminded everyone that the Combined Veterans Alliance picnic is scheduled for 13 August 2016 at the Drexel Lodge Park on West Chester Pike in Newtown Square, PA. He mentioned that signup sheets were available for those planning to attend the picnic. Dominick Mattioni also mentioned that he would be sending out e-mail messages as reminders about the picnic as the date draws closer.

Jr. Vice Commandant: Jack McLeod reported that over the recent three day July Fourth holiday, more than \$7,600.00 had been collected from area shoppers in the Help Us Help Others (HUHO) Campaign. Nineteen shifts out of a possible twenty shifts were manned by members and Auxiliary members, and the collection results were gratifying. The year-to-date total is more than \$92,000.00 collected so far in the HUHO Campaign, versus a total of \$88,000.00 collected at a similar time period during 2015.

Paymaster: Bob Spano reviewed the paymaster's report as of 30 June 2016. He provided an overview of the funds received and the funds disbursed, and he mentioned the available funds on hand. He also suggested that the membership should review the list of

organizations listed on the back of the agenda. These organizations were recently discussed at an officers' staff meeting and were being suggested to the membership for consideration in order to receive donations. George Boyajian made a motion to accept the paymaster's report as received. Chris Bush seconded the motion and the motion passed.

Chaplain: Chris Bush mentioned that Tom Kerrigan was out of the hospital and he was present in tonight's meeting. Chris Bush also mentioned that John Haynal, Jerry Powlus and Tom Falgiatore were all facing health issues. He reminded the membership to keep these individuals in their thoughts and prayers.

Service Officer: Jim Herbst mentioned that the next bingo game at the Coatesville Medical Center is scheduled for 14 July 2016. He mentioned that Con McGinley has been very helpful in assisting with the bingo games, and Jim expressed his appreciation to Con McGinley as Jim Herbst is not able to participate since he is still working during the time of the bingo games. In his role of Membership Chairman, Jim Herbst encouraged the membership to always be looking for new members. Jim Herbst also mentioned that a good number of members had turned out for the Marple Newtown Fourth of July Parade. The Detachment's Color Guard lead the Parade and they looked good.

Director Kinney: Bill Kinney provided some additional information on the third annual Delaware County Veterans Memorial Association dinner, which will be held on 17 November 2016. Bob Spano of our Detachment will be among those being awarded with recognition and medals that evening. Bill Kinney mentioned that a Detachment Color Guard will be needed again this year for the event, and the Color Guard will be joined with Color Guard units from the Valley Forge Military Academy and College and from the U.S. Marine Corps Reserve Unit in Folsom, PA. Bill Kinney mentioned that Paul Donohue will be asked to be present again in his Revolutionary War uniform. Bill Kinney mentioned that he would recommend that the Detachment purchase two tables at the dinner at \$750.00 per table plus purchasing a full page advertisement in the program book for the dinner. The tables would be available to members on a first come, first served basis. Earle Drake made a motion to purchase two tables at a cost of \$750.00 per table (\$1,500.00) plus a full page advertisement in the program book at \$350.00 for a total cost of \$1,850.00. Ben Sides seconded the motion. In discussion, George Boyajian recommended purchasing a total of three tables at \$750.00 per table, since the tables will be used for members and spouses or friends. This suggestion was tabled and will be discussed at the July officers' staff meeting. The original motion was passed.

Committee Reports

Adopt-a-Highway: Jim Flynn mentioned that the second Adopt-a-Highway event had been held on 26 June 2016 and eight members had participated. Jim Flynn mentioned that they did a great job. The next Adopt-a-Highway event is scheduled for the last week in August and further information will be announced as we get closer to that date.

Americanism: Earle Drake first reported on the Fourth of July Parade meeting, held prior to the Parade itself. June Robbins was selected as Grand Marshall of the Parade. June Robbins is a life member of the Rosie the Riveter Association for her service as a draftsman at the Philadelphia Navy Yard during World War II. It was reported that flags would be flown from Memorial Day until July 4th. In the Americanism arena, two presentations were given to summer campers at the Rocky Run YMCA.

Jim Mulhern and Earle Drake were the presenters. Earle Drake also mentioned again the possibility of a visit to the former General Butler house by Detachment members. Melissa Clarke, the current owner, has invited interested members to visit the renovated Butler house on 10 or 11 November 2016. Other possible dates were given as 28 or 29 July 2016. Earle Drake asked interested members to let him know that evening about visiting the Butler house. Earle Drake also mentioned that the Chapel of Four Chaplains exhibit will remain in the Springfield Library until 29 July 2016.

Home Association: Tom Kerrigan reported that things were “quiet” for the Home Association.

Honor Guard: Ben Sides reported that the Honor Guard participated in ten funerals for military veterans during the month of June. He also reported on several more for the current week in July. So far this year the Honor Guard has participated in seventy-six military funerals for veterans. Ben Sides also mentioned that a Chairman is still needed for the Honor Guard.

Property: Bob Spano reported that shirts and sweatshirts have been received for those members who ordered them and they can be picked up after the meeting. A red extra large sweatshirt was also available for someone interested in purchasing it. Bob Spano also mentioned that the flags outside of the Knights of Columbus Hall had been changed. A new American flag, a new Marine Corps flag, and a new POW/MIA flag are now flying over the Knights of Columbus Hall.

Communications: John Burfete reported that he continues to forward a number of communication items from Liz McCleaster, the MCL State Public Affairs Officer. In addition, John Burfete mentioned that he had sent out a press release on the recent display at the Springfield Library.

Old Business: Jack McLeod mentioned that he wanted to add to his earlier report that nine members had participated in double or triple shifts in the HUHO Campaign over the Fourth of July weekend. Other members had participated in the Color Guard or as participants riding in the wagon during the Parade, and he wanted to recognize all those members who had participated over the Fourth of July weekend.

New Business: Aleta Krauss mentioned that her observation was that over time we are having trouble filling all the slots available in the Help Us Help Others (HUHO) Campaign. She mentioned that this is a fabulous program and we are doing well in collections, raising funds and distributing funds where needed to organizations and individuals in need. She mentioned that we need to start looking to the future for the longevity of the program if we want to continue to make a difference. We need to find other ways to help support this program by finding other options to fund this program. Jack McLeod mentioned that one way he found was by contacting his church to determine if the church would consider a contribution, and it could be possible for other religious organizations to be approached to determine if they would be interested in contributing to the HUHO Campaign. Other possibilities would need to be looked into for the long range success of the program.

Earle Drake was called on to make presentations of the Legion of Honor Award from the Chapel of Four Chaplains. The Chapel of Four Chaplains seeks to encourage the observation of the unity which binds together Americans of all faiths.

Patriotic in its nature, the Chapel celebrates the characteristic, generosity, devotion to God and country, and love of fellow man which we share in common. Earle Drake provided a brief history behind the Chapel of Four Chaplains and he listed a number of names from public life who have been awarded the Legion of Honor Award in the past. This year the Chapel of Four Chaplains was awarding the Legion of Honor Award to eleven members of the Marine Corps League and two from the Montfort Point Association. Our Detachment was fortunate to have two members to be awarded the Legion of Honor Award. Earle Drake mentioned that the Award is awarded to those who go above and beyond what is expected of them in their every day responsibilities. He then listed the accomplishments of two of our members, and the Legion of Honor Award was awarded to Tom McGovern and Bill Kinney. Tom is a Navy veteran of World War II and he is a member of the Marine Corps League, the VFW, and the American Legion. He has a long record of service to others. Bill Kinney is a Marine veteran of the Viet Nam War and has served the Marine Corps League and other organizations in a selfless manner. Both received a round of applause. A certificate and pin were awarded to both men for their recognition.

Charitable Organizations: Bob Spano reviewed the list of organizations on the back of the agenda that were being recommended for consideration for donations this month. These organizations had been reviewed at a recent officers’ staff meeting and were being submitted to the membership for consideration. Two new organizations were included in the list, and these were the Make A Wish Foundation and the Fighting Back Scholarship Program. George Boyajian made a motion to donate the funds as outlined. The organizations and the amounts to be donated shown in parentheses are (1) Fisher House Foundation, Rockville, MD (\$2,000.00); (2) Coatesville VA Medical Center, Coatesville, PA (\$2,000.00); (3) The Injured Marine Semper Fi Fund, Oceanside, CA (\$2,000.00); (4) Make A Wish Foundation, Blue Bell, PA (\$1,000.00); (5) Operation First Response, Inc., Culpeper, VA (\$2,000.00); (6) Philadelphia Veterans House, Philadelphia, PA (\$2,000.00); (7) Fighting Back Scholarship Program, Malvern, PA (\$1,000.00); and (8) The USO, Philadelphia International Airport, Philadelphia, PA (\$2,000.00). Bill Kinney seconded the motion and the motion passed.

George Boyajian made a motion to adjourn the meeting. Bob Spano seconded the motion and the motion passed. After the regular closing ceremonies, the meeting was adjourned at 2025. Joe Beal won the 50/50. Thirty-three members signed the logbook.
